

# **A GREENER HOME**



(NC) Many of us would love to save on our home water and energy use. Whether your motivation is to cut your costs or help the planet or both – here are a few things you can do that won't break the bank.

### CUT BACK

Of the three r's of reduce, reuse and recycle, the first is the most powerful – and the cheapest – way to go green. It's the simple stuff you've heard of forever, but the steps can be effective. Put on a sweater instead of raising the heat as fall temperatures arrive. Cut back on long showers. Only do your laundry at off-peak hours. They may not be convenient but they're certainly cheap and effective.

### **INSTALL A RAIN** BARREL

Rather than using fresh water to tend your garden, set up a rain barrel and take advantage of wet weather. Although you won't want to drink it, rainwater is perfect for your plants. You can create a makeshift rain container yourself or buy one at a local hardware store or online. Either way should have a tap to connect a hose or fill up a watering can. Being mindful of how often you water your garden and choosing native plants that require less water can also help you cut back on water usage outdoors.

### **UPDATE YOUR** THERMOSTAT

At a basic level, a programmable thermostat allows you to set your heating and cooling in advance so you can use less when you don't need it. You might cut down on air conditioning costs since you won't have to run the system while you're out all day to still arrive home to a cooled space. Lowerend models will cost about \$50 to \$100. More advanced, "smart" models with more bells and whistles can run you roughly \$100 to \$400.

### MAKE USE OF GOVERNMENT PAYMENTS

Benefits and credits might add a little extra cash to your wallet that you can put towards energy-efficient updates. You may be eligible for the Climate Action Incentive payment if you live in a province with federal pollution pricing: Alberta, Saskatchewan, Manitoba, Ontario, Newfoundland and Labrador. Nova Scotia and Prince Edward Island. And in October 2023, eligible residents of New Brunswick will receive their first payment. The exact amount of the quarterly payments varies by region - you'll get more if you live outside a major urban centre. You don't need to apply; you just need to file your taxes every year.

# 5 AFFORDABLE WAYS TO GET FINALLY, HEALTH CANADA APPROVES 1ST RSV **VACCINE FOR OLDER ADULTS**

The department of the Government of Canada responsible for national health policy, Health Canada has approved the first vaccine for respiratory syncytial virus (RSV) for adults aged 60 and over.

Recall that prior to this historic development, doctors have been calling for an RSV vaccine for seniors because although the virus is common, older people are much more likely to become severely ill and require hospitalization.

Records have it that RSV season in Canada usually starts in the late fall and lasts until spring.

In a press statement, manufacturer GSK said a randomized clinical trial showed the vaccine, called Arexvy, was 82 per cent effective at preventing lower respiratory tract disease caused by RSV compared to seniors who got a placebo.

According to the company, the vaccine is 94 per cent effective at preventing the illness in seniors with underlying medical conditions.

Health Canada confirmed the vaccine's approval in an email to newsmen. According to the Pub-

lic Health Agency of Canada's website, for most people, including children, RSV usually causes a mild infection that goes away within a couple of weeks. Experts noted that in

addition to seniors, infants are at a higher risk of getting very sick with RSV.

According to official records, there is no RSV vaccine for children, but there are two kinds of antibody injections that can be given to high-risk babies to help prevent serious illness.

One of them, palivizumab, has often been given to babies who were born prematurely \_ but it needs to be injected about once a month during RSV season to stay effective.

It could be recalled that a new antibody drug - nirsevimab, also known by the brand name Beyfortus — was approved by

Health Canada in April. Nirsevimab only requires one injection to protect babies during the RSV season. It's not yet known how widely it will be recommended for babies in Canada this fall.

Recently, the Centers for Disease Control and Prevention (CDC) in the U.S. recommended that babies born just before or during the RSV season, as well as babies who are less than eight months old before the season starts, should get the nirsevimab shot.

The health agency also recommended that the shot should be given to some eight to 19-monthold babies who are at higher risk of getting seriously ill from the virus.

# **PRACTICAL STEPS YOU CAN TAKE TO CONTROL INDOOR HUMIDITY**



(NC) A common problem for homeowners during summer months is humidity. High in door humidity not only makes you feel uncomfortable - it can also have negative effects on your health and your home. Ideal indoor humidity levels are generally considered to be between 30 and 45 per cent. This can be a challenge to achieve during summer months, as warmer air retains more moisture.

The good news is that you can manage humidity levels effectively in a variety of ways. Homeowner maintenance is the key. There's an extra level of importance if you own a newly built home, as your warranty will not cover moisture-related issues, like damage to hardwood floors or mould, that result from improper maintenance.

Here are some things you can try to tackle excessive humidity in your home:

• Invest in a hygrometer, which will allow you to monitor humidity levels inside your home. Hygrometers are inexpensive and can be found at most hardware stores.

• Be mindful of the number or type of plants in your home as they can mean higher humidity levels inside.

• Use your home's ventilation system. Turn on exhaust fans when cooking, showering or doing laundry. It's also a good idea to leave them running for a short time after you're done to ensure enough moisture is removed from the air.

• Keep areas throughout your home as tidy as possible. Storage spaces and general clutter can interfere with air circulation, trap humidity and lead to mould growth.

• Use a dehumidifier. They are available as standalone units or can be integrated into your home's heating, ventilation and air conditioning (HVAC) system. A dehumidifier will help to remove excess moisture from the air.

• Plan your landscaping in a way that does not alter the grading around your foundation. Flowerbeds close to your foundation can cause rainwater to pool close to the structure instead of being diverted away from it.

recommends that you:

• Wash your hands

with soap and warm water for at least 20 seconds before putting on your makeup.

• Do not s hare your makeup or use anyone else's.

• Do not add water or saliva to your makeup to dilute it.

• Store your cosmetics in a dry place, away from direct heat and sunlight.

• Stop using makeup if it changes in smell, colour or feel.

• Check the label of your makeup for safety information. Always read and follow directions carefully – misuse of a product

can lead to problems like rashes, burns or eye damage.

• Do not spray cosmetics near a flame or source of heat, which can cause fires or explosions.

• Keep cosmetics out of the reach of children.

• If a child swallows a cosmetic, contact the nearest poison control centre.

# We spent N96.5bn to print, distribute naira notes in 2022 - CBN

In a shocking development that has gotten tongues wagging across the nation, the Central Bank of Nigeria (CBN) has disclosed that it spent N96.46bn to print, distribute naira notes in 2022.

This development is contained in the apex bank's recently released audited financial statement for the year ended December 31, 2022.

In the report, the CBN said: "Currency issue expenses relates to expenses incurred in relation to the printing, processing, distribution, and disposal of currency notes. This is recognised at cost when incurred."

According to data gathered by newsmen, the N96.46 billion recorded for currency issue expenses in 2022 is 32.9 percent higher from the N72.58 billion the apex bank spent in 2021.

It could be recalled that in October 2022, Godwin Emefiele, the embattled and suspended CBN governor, announced plans to redesign the N200, N500, and N1,000 naira bills.

In view of the development, people were initially given a deadline of January 31, 2023 to hand in all their old notes but it was later extended to February 10. However, not enough of the new notes were released.

Recall that the shortage of the new naira notes made it extremely hard for many Nigerians to engage in many forms of commercial transactions including transportation costs. At the time, the charges of point of sale (PoS) merchants also rose astronomically.

The untold hardship brought by the naira scarcity prompted citizens across the country to take to the streets to protest.

In a sigh of relief ruling in March 2023, the supreme court invalidated the naira redesign policy introduced by the central bank, ruling that the old N200, N500, and N1,000 notes would remain as legal tender until December 31, 2023.

# Being a farmer does not mean I cannot perform as sports minister – Enoh

The new Minister of Sports Development, Senator John Enoh, has decried critics who questioned his ability to deliver, insisting he mustn't be a footballer to provide leadership for the sports sector.

Recall that there have been uproar among stakeholders in the sector over the appointment of the 57-year-old by President Bola Tinubu, saying Enoh, a farmer and politician, had no connection with sports.

Replying his crit-ics, Enoh said "I do not think that you need to be an active participant, that you need to be either a footballer or this or that for you to be Minister of Sports Development, I do not think so".

"I think what is required is who can provide leadership, who can provide direction, who can be transparent, who can understand this sector, and

### there is no how that anybody appointed here will not try to understand this sector."

In his words, being a footballer didn't directly translate to effective leadership in sports.

"If it's about playing football or taking part in sports, I was a footballer and my schoolmates that are still in touch with me have sent messages to remind me of my playing days, after my appointment.

"It's not about that really, I could be that footballer and can't provide leadership and I'm not sure that's what you're looking for."

The minister stated that he wasn't surprised that the media focused on his farming business.

"When some people drew my attention, they said I should respond to what was written in the media, 'that he is a farmer turned sports minister and all that. 'And I said, 'Well, in my profile, you're going

to find that I'm a politician, I'm a teacher, I'm a farmer and I'm a philanthropist, so the media is free to just pick farming and blow it, isn't it?' But I also said, 'Are they not correct? How much do you know about me in terms of the sports sector?

"So, they are correct to write what they write. but now that I'm sworn in, the media will then begin to know who I am, and my hope is that it will be for a good purpose, that together we can make a difference in this sector that excites Nigerians".

# Toronto Police declare 26-year-old Oluwatobi missing

The Toronto Police Service is demanding the public's assistance in finding a missing Nigerian woman, Oluwatobi, in Canada.

In a recent tweet, Toronto Police revealed Oluwatobi, 26, was last seen on Monday, July 31, 2023, at around 9:30 p.m., in the King Street and Church Street Area. The tweet read: "Oluwatobi is described as 5'6", 160 lbs., thin build, and has long black hair. Oluwatobi was last seen wearing a dark shirt, grey pants, white shoes, and carrying a beige purse.

# An Eritrean Festival in Toronto Turned Violent

An Eritrean festival scheduled at Earlscourt Park in Toronto was disrupted by protesters, leading to violent clashes involving a knife-wielding individual, as reported by the police.

The confrontation between Festival Eritrea attendees and protesters escalated, resulting in injuries. Following police intervention, the festival briefly resumed, only to face further disruptions with the arrival of more protesters armed with weapons. The conflict eventually spilled over from the park onto St. Clair Avenue West. The City of Toronto took the step of revoking the festival's permit, a decision made 12 hours after the skirmishes began.

Both the festival organizers and protesters are part of Toronto's Eritrean-Canadian community. Eritrea's government has faced extensive criticism from human rights groups, earning a reputation as one of the world's most oppressive regimes. Eritrea gained independence from Ethiopia three decades ago, and President Isaias Afwerki has maintained power without holding elections. Millions have fled the country to avoid forced military conscription and dire conditions.

In early 2023, the United Nations Human Rights Office released a report describing the dire and unimproved human rights situation in Eritrea, citing credible accounts of torture, arbitrary detentions, enforced disappearances, and curtailed rights like peaceful protest. The country lacks elections, a parliament, independent media, and opposing political parties, as highlighted in the report.

Awet Weldemichael, an expert on the Horn of Africa from Queen's University, expressed the unimaginable conditions in Eritrea. The same ruling party and president have controlled the nation since its independence in 1998, maintaining a state of war and enforcing lengthy conscriptions in the military.

Escaping Eritrea involves hazardous journeys, often spanning the Sahara Desert and the treacherous Mediterranean or Atlantic crossings before reaching Europe. Trauma from these experiences is hard to fathom.

Weldemichael noted the direct link between the Toronto festival and Eritrea's ruling party. He emphasized that while the event has a cultural history, it is intrinsically political, aligned with the government's ideology and goals.

In a Change.org petition, over 1,700 individuals urged Toronto's Sheraton hotel to cancel a segment of the Eritrea Festival due to its association with the government's totalitarian regime. The petition contended that the event contributes funds to support the regime's military.

Nigeria's Federal Competition and Consumer Protection Commission (FC-CPC) has deleted the list of approved loan apps in Nigeria from its website.

While talking about the development on its website, FCCPC said: "The list is undergoing a cleanup and will be made available as soon as possible."

Recall that the commission revealed that some registered Digital Money Lenders (DML) apps approved to operate quick loans in Nigeria have duplicated their apps by operating an Android app on Google Playstore and Android Package Kits (APK) file formats.

FCCPC said Sycamore Integrated Solutions Limited and Orange Loan and cial services providers.

"The violating DMLs have resorted to the use of Android Package Kits (APK) file formats. The illegal DMLs provide links to consumers to visit unregistered websites using their Android devices/phones. In the course of that interaction, consumers' private information that is otherwise protected and prohibited from access or download by DMLs or their apps is accessed and downloaded. This conduct is prohibited by sundry laws, particularly relevant data privacy protection instruments, and more specifically, the Limited Interim Regulatory/ Registration Framework & Guidelines for Digital Lending 2020 of the Commission.

### **Former Canadian Armed Forces** HR Head faces sexual assault trial

# Is joint account a good idea? My Parents were wicked

In view of the high rates of infidelity among married couples, is it safe for a couple to operate a joint account? The experiences of many couples on this issue aren't pleasant. My elder brother's experience prompted my query to you. He woke one morning to find himself homeless after discovering his wife has been having extramarital affairs, and that the two children she passed off as his', belonged to two different men she had affairs with.

In addition, with the help of one of the men she is involved with, she was able to sell piece off their house, using the documents of their joint account, without the knowledge of her husband, who was on official assignment in Ghana when the sales were made.

Many married couples who have joint accounts, do not have good stories to tell.

What do you think, Agatha?

Dear Chioma, My stance on your query remains the same as other times, I have responded to similar questions.

The issue of joint remains a major problem in marriages, not because the conception is wrong, but has its major flaw, in the sincerity of the couple involved.

No thanks to the nasty experiences of some

couples, many others are increasingly finding it difficult to trust each other with money.

It's a sad commentary about the fragile foundation must marriages are premised. A lot of marriages lack sufficient credible credentials to survive the different challenges that come with sharing everything together.

Sincerely, having a joint account and helping to fund the building of a house are foreign adaptations which are painfully today destroying most marriages in this side of the world.

This is because traditional African society was a simple one: one in which the man worked to fend for his family while the woman's duty was to take care of her husband and children.

Her job was inside her home. But with more exposure to Western values, so many things changed in the way we do things. Unfortunately from available statistics, the marriage institution has become the major casualty of this desire to adapt everything Western without questions. Whether we agree or not, there are certain marital norms in the West that will not work here in Africa and the earlier modern Africans realized that, the better for the marriage institutions.

For starters, our laws are not designed to protect the woman in anyway so why premise a marriage on the values of a society that has evolved a system that makes the man not only a tenant in his own home,

but forces him to continue to part with almost half of whatever investments he has should the woman sue for divorce?

First and foremost, the typical African man is a polygamist by nature. Whether we admit it or not, the inherent nature of the men generally is to conquer as many women as possible. Down here in Africa, polygamy is still a very strong part of our nature. Unlike the Western world where the society from its inception has inculcated and entrenched monogamy, the average African man has polygamy in his blood and history.

Also, down here, women in those days, were expected to be submissive and absolutely faithful to their partners. Not so anymore as more and more women these days, think having extra marital affairs, is the major criterion for showcasing the independence of women.

The flip of this argument is, how does a woman who grew up with a father who had many wives and concubines ever trust her money and labour to a man without always being suspicious of his reasons for withdrawing money from a joint account or wonder what would be her faith if she invests alongside her husband in building a house for the family?

Often than not, couples only focus on why they want to; the reasons are usually for housekeeping and having enough funds to take care of the children's fees.

A personal mobile phone for emergency use is a common way to help stay connected, however, most campuses also have well-marked emergency phones to use in the event someone is being followed or harassed. Public transit systems often have designated safe waiting areas as well.

### TALK ABOUT HUMAN TRAFFICKING

While many people think of human trafficking as an issue that doesn't happen close to home, every year Canadians across the country are taken advantage of and exploited for sexual or labour purposes

Teach your kids about what human trafficking is and what traffickers may do. Some traffickers may isolate kids from friends and family, pressure them into providing services to earn love, pay back favours or gifts, or to show gratitude. Traffickers may even show romantic interest or offer fake job opportunities.

# **Teachers in Ontario settle** labour complaint, early reading screening equipment not mandated

Two Ontario teachers' unions revealed they have settled unjust labour practice complaints against the government, with Ontario agreeing not to mandate an early reading screening apparatus for the forthcoming school year.

Recall that the Elementary Teachers' Federation of Ontario (ETFO) and the Ontario English Catholic Teachers' Association (OECTA) accused the government recently of not bargaining in good faith by presenting the new requirement since it is a subject matter of discussion in negotiations.

The four paramount teachers' unions have been in bargaining for a new contract with the government for over a year and three say they are plotting strike votes this fall.

A new policy announced by Education Minister Stephen Lecce in early 2023 would have required teachers to utilize an early reading screening tool in senior kindergarten, Grade 1 and Grade 2.

A joint statement Wednesday from ETFO and OECTA says though they firmly believe that every child has the right to learn, to read, their contracts include language on the capability of teachers to exercise their professional judgement when selecting and conducting diagnostic tests to meet student needs.

They said the settlements were reached recently and the government confirmed the early reading screening tool would not be compulsory for the 2023-24 school year and that educators will still "use their expertise to identify and address students' unique individual needs."

Make sure your kit is organized and easy to find. You may also buy a pre-assembled emergency kit or a car kit online and in various retailers.

# HOW GOD APPEARED TO ME, CALLED ME INTO MINISTRY - PASTOR AMOS DADA

continued from p(1) NCNC: Thank you for creating time to have this interview with us. You're quite an accomplished preacher. Where are you originally from and why did you move to Canada? What are some of the childhood experiences that shaped who you are today?

16

Pastor Dada: bm grateful to God for preserving both us and the ministry for two decades. Thanks to Nigerian Canadian news for this opportunity. Being a pioneer columnist for spiritual matters has been an honor. Originally from Nigeria, I schooled there worked there and by the grace of God prospered there. Ive found purpose in Canada beyond economic reasons—to bring a spiritual awakening and put Canada on the global spiritual map, as directed by a prophetic message, to come to this country to raise an eagle generation and put Canada on the spiritual map of the world. I always imagine if I was not educated I would be languishing in on one farmland, my greatest ambition was to become a taxi driver. Childhood experiences that shaped my life include my parents> prayers and their determination to educate me despite their lack of schooling. Education rescued my family from generational poverty.

NCNC: You're a Chemical Engineer by training, a field considered to be very lucrative. Why are you not practicing as an engineer?

Pastor Dada: I spent two decades in Chemical Engineering (1981-2001) as a teacher, lecturer, and process engineer before finding my true purpose. Notably, I had

already made an impact in Chemical Engineering before embarking on my journey in «Jesus Engineering.» My doctoral research focused on finding an alternative to the melt flow index for polypropylene polymerization, which successfully reduced downtime at Warri Refining and Petrochemical Company, a subsidiary of the Nigerian National Petroleum Corporation. I am practicing engineering it is just that instead of refining oil I am refining souls!

NCNC: Your profile reveals that you're a Preacher, Teacher, Pastor, and Evangelist by calling. How were you called into ministry and how did you know that it was God who called you?

Pastor Dada: In a very dramatic way. I was very good in playing draft - (a well-known local game in the western part of Nigeria in those days) in my university days, instead of staying awake in the reading room I was wasting away in the common room. During IT in Ibadan with my uncle, he will put me among people as old as my parents, grandparents, I was happy I was winning the game but I realized the old people hated it and could use their diabolical powers to hurt me. So, I was in search of God. One day in a small library in Fajuyi Hall of Obafemi Awolowo University after reading a tract I gave my life to Christ. The prayer I prayed that day in line with the story of the tract, was "God speak to me tonight and if you do, I will serve you all my life." God did not just speak to me that night, he appeared to me, I did not see his face he was in a white dazzling garment, tall but he stretched the Bible to me. I took it in that revela-

tion and told my classmates, that I am now born again, and I will preach the gospel around the world. NCNC: There is a popu-

lar notion that when some persons are unable to find a job or could not find anything meaningful to do, they venture into ministry, claiming that God called them. How would you react to this and, was that the case for you?

Pastor Dada: Absolutely true. God>s ways of calling people to ministry are diverse, and He uses them to advance His gospel. His sovereignty cannot be confined. The early church's expansion stemmed from persecution, even leading Paul to Rome through his appeal to Caesar. Persecution birthed the Catholic Church, which has blessed humanity immensely. Their preservation of historical sites in Israel is remarkable. Even if unemployment guides individuals to find purpose and service, all glory goes to God.

NCNC: Many people believe that most clergy men are into ministry because of tithes and offerings? Do you think Churches will continue to exist if tithes and offerings are halted?

Pastor Dada: Tithes and offerings are rooted in

both the Old and New Testaments, and as long as there are believers on earth it cannot be halted. True believers don't question giving; they understand its role in spreading the gospel.

NCNC: Your profile says in 2003, as "directed by the Lord," you and your wife commenced International Gathering of Eagles Conference, "this is one way by which he has been used of God to put Canada on the spiritual map of the world". Can you share insight on this initiative? What is the evidence that it has put Canada on the spiritual map of the world?

Pastor Dada: Certainly, here are five ways that showcase our impact as Canadians through the conference. Global Conferences: Our conference presence in 45 nations stands as strong evidence; Transformative Stories; Church Planting and Missions; Inbound Learning and Transformation; Authoring Global Impact.

NCNC: The International Gathering of Eagles Conference (IGOE) 2023 comes up from September 14 to 17, at the Jewel Event Centre, marking the 20th anniversary. What are the expectations at this year's Conference?

Pastor Dada: The purpose of The International Gathering of Eagles Conference is multifaceted: to lead the unsaved to Jesus, nurture immature believers into maturity, bring healing and deliverance, and ignite a passionate spirit for Christ. Our vision aims to raise a generation of dedicated, Spirit-filled individuals who spread the gospel with integrity, not just in Canada but globally. We emphasize solid, undiluted biblical teachings for church maturity.

This years theme, «Worship God in Spirit and in Truth,» focuses on genuine, faithful worship that pleases God. Our goals include teaching proper worship, addressing misconceptions, emphasizing worship's significance, motivating global energetic worship, and equipping attendees with worship tools.

NCNC: You're an advocate of 'no divorce'. In a situation where one party consistently threatens another's life, what would you advice considering that domestic violence has sent so many married people especially women to early grave?

Pastor Dada: I advocate against divorce, based on adherence to the Holy Bible principles. Love between spouses should never involve violence. Husband love your wife and wife submit to your husband should be a simple way to live. Jesus links divorce to hardened hearts, so avoid that. Do not abuse each other in any way. Don't go to marriage until you are the right person. I have five daughters; I don't want any man to kill them and vice versa. My no divorce message has an exception - no violence. If a spouse is violent, seek help

and prioritize your safety.

NCNC: What are some of the personal challenges you have faced as a Preacher and how did you tackle them? Finally, considering that we are in the end time, what advice do you have for the general public?

Pastor Dada: God has been good to me. However, like other minister we have faced a lot of challenges and God has given me victory. The greatest challenge was the church God enabled us to plant in our youthful days, for 16 years, that we left in the hand of faithful men, when we emigrated here the Pastor denied that we were the pioneers. That was very challenging. I am grateful this was resolved and we are able to continue to do God's work in unity. To the glory of God in 38 years of ministry 1985-2023, we have not had cause to bury any member whether in Warri church when we were there or the Toronto Church. However, in 2012 after the conference a speaker's wife died before they could travel back. That was a tough time. But as they say tough times don't last only tough people do. Challenges of investing in members with the hope that after you have trained them, they will become resources persons in the church are there; they either leave or fail to give back.

Whatever vision God has given you engage in, follow these four steps, determination, discipline dedication and sacrifice.

Finally, I want to thank all the people that God has used within and outside the church for all that God has used to help our ministry in the past 38 years and especially 20 years in Canada, you are blessed.

# **BRITISH COUNCIL INCREASES IELTS FEE**

British Council has announced its decision to revise the fees for the Academic and General Training Modules of the International English Language Testing System (IELTS) examinations for candidates in Nigeria, starting September 2023.

The revised fees will be N107,500 for IELTS Academic and General Training Modules, and N116,000 for the UK Visas and Immigration variant.

Also, the fee for Life Skills assessments will be N104,000.

IELTS remains a requirement for individuals all over the world aspiring to pursue work or educational opportunities in the United Kingdom, Canada and other countries.

The present cost of the examination in Nigeria ranges between N80,000 and N90,000, a figure that highly surpasses the country's minimum wage of N30,000.

Officials of British Council have justified the fee adjustment, highlighting the importance of upholding the benchmark of excellence associated with the testing experience.

In a message written to test takers, the British

Council said: "Dear valued Test Taker, We would like to inform you that effective from September 1, 2023, there will be a price increase for IELTS tests offered by the British Council.

"The new prices will be NGN 107,500 for IELTS Academic and IELTS General Training, NGN 116,000 for UK Visas and Immigration, and NGN 104,000 for Life Skills.

"The new prices are necessary to sustain the high quality of standards for your testing experience."

The Prime Minister of The Bahamas, Philip "Brave" Davis has maintained his stance that the level of violence against women and girls in the nation remains unacceptable.

The PM made the remark to a crowded Atlantis ballroom during the opening of the 13th Commonwealth Women's Affairs Ministers Meeting.

He said "We can't stop working on this issue until women are safe everywhere – whether they are walking alone at night, in their workplaces and schools, or at home with loved ones".

According to police, there has been an uptick in the number of reported rapes and sexual assaults of women and girls this year.

It was gathered that the meeting, hosted by The Bahamas, will serve as a "decision-making body for Commonwealth women's affairs ministers to review progress made towards achieving four Commonwealth priorities for gender equality and women's empowerment".

Official records have it that the priorities include women in leadership; women's economic ending empowerment; violence against women

and girls; and gender and climate issues.

In his speech, Davis highlighted his government's efforts to tackle a variety of issues affecting women in The Bahamas, mainly gender-based violence.

He said "My administration has sought to address the social and systemic factors contributing to violence against women and girls through increased funding to construct a new women's shelter and to provide legal aid for survivors of domestic violence through social services and the Office of the Judiciary".

"We have also made meaningful progress in protecting survivors of domestic abuse and sexual violence through the recently passed Protection Against Violence Act, which establishes and protects the rights of victims, allows for the allocation of more resources, and focuses on sensitization and training within the police force and other organizations that work directly with survivors." Women's groups in

The Bahamas were critical of the Protection Against Violence Act, noting that it was not the Gender-Based Violence Bill that they worked on "for over a decade".

According to the concerned PM, it is critical that "we constantly evaluate how different issues affect members of our population differently, and make sure we are designing policies that are effective for all".

"The time is now for our Commonwealth community to be unabashedly ambitious in our goals and plans. We need more than slogans - we need commitments," he said.

Prime Minister Narendra Modi joined a conference call at the space centre to watch the landing, waving a small Indian flag as the spacecraft landed.

In his triumphant speech to the Indian Space Organisation Research (ISRO), Modi said: "This is the heartbeat of 1.4 billion people. This is the new India, the new beginning, the

dian, we are all very proud." Turning his attention

to the wider world, he said: "India's successful moon mission is not just India's alone. We can all aspire for the moon and beyond."

According to the PM, India will now look into a future human flight mission to the moon.

Thousands of people across India crowded in offices, shops, homes and restaurants eagerly waiting to witness the outcome of the mission.

Official reports have it that in view of the successful landing, Chandrayaan-3 will only remain functional for two weeks, during which it will run a series of experiments to determine the mineral composition of the moon's surface.

It was stated that much of the work will be done by a rover, which will be deployed by the spacecraft's two-metre-high lander.

It is germane to note that scientists have a particular interest in water ice, as it could be used for fuel, oxygen, and drinking water - with the mission laying the groundwork for a potential permanent base.

Records have it that India's landing follows Russia's failed attempt, after their Luna-25 spacecraft crashed into the moon.

# **JACOB ZUMA LEAVES PRISON**

The embattled South Africa's former president Jacob Zuma has been released from prison, in a move that the Correctional Services national commissioner said was part of a remission program aiming to address prison overcrowding.

Defending their decision, authorities and correctional services said "The law has taken its course with regards to the former president Zuma. The national commissioner has taken a decision and that decision was not interfered with, neither did we meddle with it."

The Justice and Correctional Services minister Lamola said the former leader immediately benefited from a remission of non-violent offenders approved by President Ramaphosa.

Makhothi Thobakgale, correctional services commissioner said under the remissions process authorized by President Cyril Ramaphosa, almost 9,500 inmates will be released from prison and placed under correctional supervision.

Recall that Zuma was jailed in 2021 for defying a Constitutional Court order to appear before a commission of inquiry investigating allegations of corruption during his tenure as president from 2009 to 2018.

He was released on medical parole two months into his 15-month sentence but had been sent back.

Reports had it that the then correctional services

He added that "It is with deep shame and regret that we acknowledge our ancestor's involvement in this crime and with heartfelt sincerity that we apologise to the descendants of the enslaved in Guyana".

"We also urge other descendants of those who benefited from slavery to open conversations about their ancestors' crimes and what they might be able to do to build a better future."

The Gladstones also apologised for their role in indentureship.

However, local reports said his words were met with a strong rebuke by several Guyanese descendants of African slaves present at the university lecture hall.

"It is not accepted," one of them shouted. The protesters held placards that read: "Your guilt is real Charlie. Move quickly to reparations now," and "The Gladstones are murderers."

# **U.S approves oral pill for postpartum** depression for first time

The United States' Food and Drug Administration (FDA) has approved Biogen (BIIB.O) and Sage Therapeutics' (SAGE.O) oral pill to treat postpartum depression (PPD) in adults. Recall that the companies had sought the FDA's approval for the drug, Zurzuvae, to treat major depressive disorder

(MDD), or clinical depression, as well as postpartum millions of people.

According to experts, PPD severely affects a woman's ability to return to normal functioning, while also potentially affecting the mother's relationship with her child.

Sage Therapeutics and Biogen said in a statement "Zurzuvae is expected to launch and be commercially available in the fourth quarter of 2023 shortly following scheduling as a controlled substance by the U.S. Drug Enforcement Administration, which is anticipated

to occur within 90 days".

According to the depression, which affect statement, the FDA issued a Complete Response Letter for the New Drug Application for Zurzuvae in the treatment of adults with MDD. The letter said the application did not provide substantial evidence of the effectiveness of Zurzuvae for treating of MDD and that additional studies would be needed to support the approval. Sage and Biogen said

they were reviewing the feedback and evaluating next steps.

Analysts have anticipated that the stocks of both companies would fall if the drug was approved only for postpartum depression, due to the smaller patient population.

Recall that before now, the FDA said treatment for postpartum depression was available only as an intravenous injection.

It could also be recalled that in 2021, an estimated 21 million adults in the United States had at least one episode of major depressive disorder, which is characterized by a persistent feeling of sadness. Official records have it that PPD affects around one in seven women who give birth.

In a recent statement, the Mesquite Independent School District said the teacher, who is black, was no longer with the school after officials became aware of "alarming, racist" posts she tweeted.

The school system said: "As of this morning,

the employee is no longer a part of the Mesquite ISD organization and is not eligible for rehire.

"Nevertheless, the highly offensive statements posted to her X account do not reflect the values and standards of Mesquite ISD, and the district condemns them in the strongest terms."

The school added officials can't say more because it's a personnel matter.

According to posts reviewed by the Dallas Morning News, the teacher reacted by saying she was upset her sister was dating

a white man and joked that she asked her boyfriend to kill him.

In a post, she reportedly wrote: "I enjoy being a racist. I'm never changing."

The newspaper reported that she used derogatory words for white people in other posts.

The teacher, whose Twitter handle is Claire Kyle, has deleted her account from the social media platform.

The teacher described herself as a "Black Supremacist" in her social media account bio and stated that her job knew about the posts before she was employed.

The teacher said: "Yes. Y'all have found my job. They told me to delete the post but my job is safe since I did not directly wish harm on ALL white people.

"They laughed and told me to watch what I say and I'll be good to go!"

According to Dallas Morning News, the teacher taught third grade for three years at Thompson Elementary School and taught at the district for four years.

the greatest honours for any athlete to do so, and anyone who chooses not to represent Jamaica, especially when it's about decisions made transparently, fairly and within the rules, will have their wishes respected without apology and without our looking back," Azar said.

Multiple reports have it that Bicknell and Azar have been at loggerheads recently, with several letters being exchanged regarding the selection process that seven-member Tennis Jamaica technical committee, which upheld the decisions, which were then ratified by the body's board. Azar said his wife and himself recused themselves from the voting process.

He further revealed that the process was outlined to Bicknell at a meeting on August 9, with the player seemingly accepting the explanation but he, subsequently, still sent a letter to the association on August 20 with the "thinly veiled threat".



Opponents of the festival argue that it bolsters a repressive regime by financing its operations, including forced conscription. Dawit Demoz, aligned with the protesters and an Eritrean refugee, highlighted the trauma induced by lice support prior to the the event's association

with the government that caused their escape. He pointed out the lack of economic opportunities and the regime's reliance on the diaspora for support.

Democratization of Eritrea is hindered by the festival's link to the regime, which represents a stark generational divide. Those who experienced Eritrea under Ethiopian rule link the current government to independence, while younger refugees directly experienced the regime's brutality.

In response to violent incidents, the City of Toronto prioritized public safety and revoked the festival permit, originally intended for the long weekend.
